Entries to be judged must be in parade lineup by 12:00 noon. Judging begins promptly at 12:15 p.m.
No Exceptions!

Judges decisions will be determined by scoring on a point system based on:

1. **Originality**
2. **Workmanship**
3. **Portrayal of Theme**
4. **Artistry**

Entries will be rewarded for: **Good Construction:** all components firmly attached and secure
Visibility: name of sponsors and theme of float on both sides of entry
Costumes: complementing the theme of your float, **no participants wearing Santa Claus costumes will be allowed.**
There will be only one live “Official Santa Claus” in the parade.
Appropriate Dress – riders dressed for winter weather and placed so that their personal safety is guaranteed.

All floats must have a fire extinguisher on board.

RULES AND REGULATIONS

2018 Elkmont Lions Club Christmas Parade “*The Carols of Christmas*”

1. All floats and entries must be decorated in good taste depicting the parade theme.
2. Parade entries not meeting visual standards will be pulled prior to or during parade.
3. Entries will be removed by 12:10 if they are not decorated.
4. The use of inappropriate language is prohibited and will not be tolerated. Entries with inappropriate dress, music and/or behavior will be pulled prior to or during the parade. This decision is at the discretion of parade officials as well as law enforcement officers of the Town of Elkmont and Limestone County.
5. All entrants must obey law enforcement and instructions given from parade officials.
6. Do not remove or go around barricades. They are there for safety purposes. Violators may be fined.
7. No vehicles will be allowed in the parade lineup area without a parade entry pass.
8. **Four-wheelers, three wheelers, mini bikes or go-carts are prohibited from participating in the parade.**
9. All floats are required to have a fire extinguisher on board. Be prepared to show it to parade officials upon entering parade lineup area.
10. No vehicle can be over **15 feet high**.
11. No music other than traditional Christmas music can be played over public address or car stereo systems.
12. The consumption of alcohol before or during the parade is strictly prohibited.
13. Drivers of vehicles in the parade must be at least **18 years of age** or older, have a valid driver's license and auto insurance.
14. For parade safety, and to maintain smooth progression of the parade, do not under any circumstance, hand out, throw, or distribute any food, literature, coupons or souvenirs during the parade.
15. No cruelty to animals is permitted. Do not ride horses down the parade lineup area prior to start of parade.
16. **No Santa Claus costumes will be allowed on parade entries**, to do so will disqualify entry from being judged for cash prize. Only one “*Official Santa Claus*” will be included in the parade.
